# Disclaimer for Mary Magdalen, The Divine Feminine Wisdom and The Sacred Union Retreat (September 27th – October 3rd 2025)

By registering for and attending the **Mary Magdalen**, **The Divine Feminine Wisdom and The Sacred Union** retreat (hereafter referred to as the "Retreat"), you acknowledge and agree to the following terms and conditions. These terms are designed to ensure the safety, well-being, and mutual respect of all participants while preserving the integrity and sacredness of the Retreat experience.

## 1. Acknowledgment of Risks

## 1.1 Physical Risks

# 2. Release of Liability

#### 2.1 Waiver of Claims

By attending the Retreat, you waive, release, and discharge the Retreat organizers, facilitators, staff, contractors, and associated parties (hereafter referred to as the "Released Parties") from any and all claims, demands, or causes of action, whether direct or indirect, related to physical

injury, illness, emotional distress, loss of property, or damage incurred during your participation in the Retreat, regardless of whether caused by the negligence of the Released Parties or otherwise.

## 2.2 Limitation of Liability

# 3. Third-Party Contractors

# 6. Disruption or Termination of Participation

The Retreat organizers reserve the right to refuse or terminate your participation if your behavior is disruptive, unsafe, or incompatible with the sacred nature of the Retreat. In such cases, you will be required to leave the Retreat immediately, and no refund will be provided.

#### 6.2 No Refund for Early Departure

If you choose to leave the Retreat early for any reason (personal, medical, etc.), no refunds will be provided for the unused portion of the program, and you will remain responsible for the full cost of the Retreat as outlined in the refund policy.

# 7. Cancellation and Refund Policy

#### 7.1 Cancellation by Participant

- Cancellations made before August **31**, **2025**, will receive a 50% refund
- Cancellations made after August 31, 2025, are non-refundable.

#### 7.2 Cancellation by Organizers

In the event that the Retreat is cancelled by the organizers due to unforeseen circumstances, participants will receive a full refund. The organizers are not responsible for any additional costs incurred (e.g., flights, travel expenses).

#### 7.3 Transfer of Booking

Participants may transfer their booking to another individual, subject to approval by the organizers and any applicable administrative fees.

#### 7.4 Force Majeure

In case of force majeure events (e.g., natural disasters, pandemics, political instability), the organizers may reschedule or cancel the Retreat. Refunds or credits will be provided based on specific circumstances.

## 8. Indemnification

#### 8.1 Indemnity Agreement

This waiver constitutes the entire agreement between you and the Retreat organizers, superseding any previous discussions or agreements. By participating in the Retreat, you confirm that you have read, understood, and agree to all terms outlined in this disclaimer.

#### 10. Agreement to Terms
